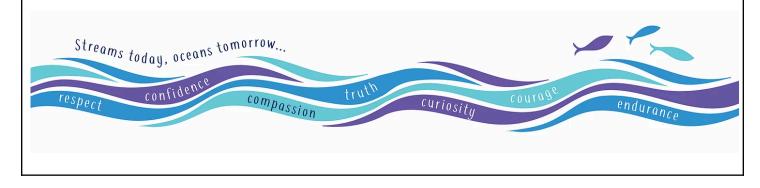

Additional 1:1 and small group teaching - teacher to work with individuals and groups. Some smaller classes (no more than 2 year groups per class) KS2 focus on reading, writing and maths KS1 focus on Early reading	'Good teaching is the most important lever schools have to improve outcomes' This approach has been used in previous years to support children to make good or better progress. Teachers use this time to pre-teach or revisit concepts. Termly Assessment and Pupil review meetings enable teachers to identify support needed.	2,
